TIMELY NOTIFICATION BULLETIN
Possible Threat to the Community
“Your Right to Know”
February 6, 2009

In compliance with the provisions of the federal **Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1998**, the Fayetteville State University (FSU) Campus Police are giving notice of an alleged disturbing act of violence reported to have occurred on the campus of Fayetteville State University.

On Friday, February 6, 2009, an alleged robbery of an individual was reported to campus police and administrators. The incident allegedly occurred on Friday, February 06, 2009, at approximately 4:00 p.m. while the victim was attempting to purchase a second-hand item from acquaintances while on the Fayetteville State University campus. The victim reported that while he was purchasing an item from the acquaintances (suspects), the suspects indicated that they were armed with handguns. The suspects then robbed the victim of the property. After the suspects obtained the victim's property, the suspects left the area in an older model baby blue four-door Buick.

The suspects' descriptions are as follows:

Suspect 1: Black female, approximately 5'5", approximately 250 pounds, heavy build, medium complexion, and approximately 24-27 years old. Suspect 1 had short black colored afro-style hair and wore a loop-style ring with a pink pearl on the right side of her bottom lip. Suspect 1 was wearing a white polo shirt with black and baby blue horizontal stripes, a black zip-up style hooded sweat shirt, and shiny black shoes.

Suspect 2: Black male, approximately 6'2", approximately 160-190 pounds, slim build, light complexion, and approximately early to mid 20's. Suspect 2 had black colored shoulder length dreads and some facial hair. Suspect 2 had a gold colored front tooth cap. Suspect 2 was wearing black pants, a black toboggan, a purple hooded jacket with green designs on the back, and a pair of black and purple Nike Air Force One tennis shoes.

Suspect 3: Black male, approximately 6'2", approximately 180-190 pounds, slim build, dark complexion, and approximately 25-27 years old. Suspect 3 had short black hair and some facial hair. Suspect 3 had a "wandering" or "lazy" left eye. Suspect 3 was wearing a black zip-up style hooded sweatshirt jacket and a pair of black pants.

Suspect Vehicle: Baby blue, older model (possibly early 1990's model), four-door Buick with faded paint.
