COMMITTEE ON ATHLETICS WEDNESDAY, SEPTEMBER 25, 2024 10:30 A.M.

The Committee on Athletics of the Fayetteville State University Board of Trustees convened on Wednesday, September 25, 2024, in the Rudolph Jones Student Center, Multi-Purpose Room and via Microsoft Teams. The meeting was called to order at 10:33 a.m.

ROLL CALL

The following Trustees Kimberly Jeffries Leonard were in attendance: Mr. John McFadyen, Ms. Johnae Walker, Mr. Greg Pinnix, and Dr. Kimberly Jeffries Leonard.

Staff in attendance were Mr. Anthony Bennett, Atty. Wanda Jenkins, and Mr. Deron Norwood.

APPROVAL OF MINUTES

It was moved by Trustee Kimberly Jeffries Leonard that the minutes of the Committee on Athletics meeting held on March 27, 2024 and June 12, 2024, be accepted as printed and distributed. The motion was seconded by Trustee Johnae Walker. The motion carried.

ATHLETICS UPDATE

Athletic Director Todd Bennett opened the committee presentation providing an overview of the compliance process set by UNC System policy for managing state funds within intercollegiate athletics—in which 36% of the Department of Athletics Fiscal Year 2025 budget is comprised of state funding. The policy requires that each UNC System institution submit a proposed athletics department operating budget and a five-year budget projection. Further, AD Bennett shared the UNC System's policy requirements for transferring, joining, or removal from an athletic conference association. Trustee Moore asked about the minimum salary requirements and number of coaches.

Next, AD Bennett introduced Mr. Deron Norwood, Associate Athletics Director for Compliance. He provided an overview of the Name, Image, and Likeness (NIL) Policy. The Athletics Department works with the student athletes to stay in compliance with variations across state laws, conflict of interest rules, and disclosure statements, among other guidelines set by the NCAA. Mr. Norwood also emphasized their role in teaching financial literacy as students participate in NIL deals. Trustee Jeffries Leonard asked about guidance prohibiting deals that conflict with FSU's values and policies (e.g., tobacco and alcohol). AD Bennett and Mr. Norwood reiterated certain restrictions from some companies. Trustee Moore asked for clarification on restrictions from competing companies. Trustee McFadyen

reiterated the need for financial literacy.

Further, Mr. Norwood discussed recruiting guidance and trending risks regarding institutional control. The Athletics Department continually works with several entities throughout the recruiting process to minimize chances for NCAA violations, conflict of interests, reputational threats, legal and ethical risks, as well as student-athlete welfare.

ADJOURNMENT

The Committee on Athletics adjourned at approximately 11:08 a.m.






CIAA WOMEN'S VOLLEYBALL RUNNER-UPS




OVERALL GRADUATION RATES (%)


GRADUATION RATES (%) FEMALE STUDENT-ATHLETES

GRADUATION RATES (%) MALE STUDENT-ATHLETES



RETENTION RATES MALE STUDENT-ATHLETES





SELF SUFFICIENCY FY25 ATHLETIC BUDGET






WOMEN'S VOLLEYBALL SCHOLARSHIP COMPARISONS
