BF-1, Approval of All Funds Budget for FY 2024-2025



- The All Funds Budget is an initiative by the UNC System to provide operating budget information across all University fund types.
- It was developed to better align resources with the University's strategic priorities and to promote stewardship and financial sustainability.
- The All-Funds Budget requires Board of Trustee approval.

BF-2, FSU Health & Wellness Center Project: Increase in Project Authority



- Current project authority is \$11,100,100.
- The FSU BOT approved up to \$1,000,000 in additional authority in February 2024. The UNC System Office informed FSU that the source of that additional authority is not eligible to be transferred to the HWC project.
- Request is for an additional \$250,000 in project authority to increase the total project authority to \$11,350,000.
- The additional authority will be funded from two sources:
 - FY22-23 Carryforward funds
 - FY20-21 Carryforward funds
- The additional authority will address construction cost escalation.





- The funding sources for the \$450,000 project have changed since the project authority was first approved in May 2023. Originally the funding source was identified as "Title III funds."
- The new funding sources are:
 - FY21-22 Carryforward: \$130,622
 - Title III FY22-23 Carryforward: \$219,582
 - FY22-23 Carryforward: \$60,000

BF-4, Campuswide Hardscape & Exterior Lighting: Increase in Project Authority



- Current project authority is \$1,779,000.
- FSU requests an additional \$1,150,000 in project authority to increase the total project authority to \$2,929,000.
- The funding source for the additional authority is Title III Infrastructure Improvement FY21-22 Carryforward funds.
- The additional authority will address additional exterior lighting scope on the East Quad and Campuswide exterior lighting projects to improve lighting, safety and security on campus.

BF-5, Butler Building Renovation: Increase in Project Authority



- Current project authority is \$3,745,000.
- FSU requests an additional \$100,000 in project authority to increase the total project authority to \$3,845,000.
- The funding source for the additional authority is Title III FY22-23 Carryforward funds.
- The additional authority will address support additional mechanical and fire alarm equipment in the Butler Building.

BF-6, Science & Technology Fume Hood Repairs: Increase in Project Authority



- Current project authority is \$275,000.
- FSU requests an additional \$200,000 in project authority to increase the total project authority to \$475,000, and to correctly identify the original funding source of the original project authority.
- The funding source for the both the original and additional authority is Title III FY22-23 Carryforward funds.
- The additional authority will support additional project scope and ensure the fume hood repair project is ultimately successful.





- Current project authority is \$100,000.
- FSU requests an additional \$200,000 in project authority to increase the total project authority to \$300,000, and to correctly identify the original funding source of the original project authority.
- The funding source for the both the original and additional authority is Title III FY22-23 Carryforward funds.
- The additional authority will support additional project scope and ensure the LS Observatory repair project is successful.

BF-8, Collins Building Chiller Replacement: Clarify Project Authority Funding Source



- Current project authority is \$175,000.
- When the project authority was approved by the FSU BOT in February 2024, the funding source was not specified.
- The funding source for the \$175,000 project authority is FY22-23 House Bill 1292 Energy Savings Carryforward funds.

BF-9, Classroom Card Access: New Project Authority



- The proposed project will purchase and install new on-line electronic card access hardware on approximately 220 classroom doors. The new on-line hardware will be integrated into the current campuswide card access software platform.
- FSU requests \$900,000 in project authority.
- The funding source for the authority is Title III Infrastructure Improvement FY21-22 Carryforward funds.

BF-10, Academic Area Interior Lighting: New Project Authority



- The project will purchase and install new interior lighting in instructional spaces on campus.
- FSU requests \$300,000 in project authority.
- The funding source for the authority is Title III Infrastructure Improvement FY21-22 Carryforward funds.

BF-11, Academic Area Furniture: New Project Authority



- The project will purchase and install new furniture in instructional spaces on campus.
- FSU requests \$500,000 in project authority.
- The funding source for the authority is Title III Infrastructure Improvement FY21-22 Carryforward funds.

SUBJECT Increase in Project Authority- Health and Wellness Center

BACKGROUND: Board of Trustees approval is required for new capital

projects or additions in construction project budget authority for previously approved projects. The original project authority for the Health and Wellness Center project was \$5,500,000 from a State of North Carolina capital appropriation. In 2019 the FSU Board of Trustees and the UNC Board of Governors approved an increase in authority to \$7,500,000 based on City of Fayetteville funding. Because those City funds are no longer available, only the original

\$5,500,000 State of North Carolina capital appropriation

remained. I V F R S I T Y

The Higher Education Emergency Relief Fund (HEERF) regulations were revised in 2022 to allow for more flexibility for the funds to be used on construction projects.

By 2022, the original scope of the \$5,500,000 HWC project had eroded due to construction cost escalation.

In June 2022, the FSU BOT and UNC BOG approved to increase the project authority to \$11,100,000 using \$5,600,000 of available HEERF funds. The U.S. Department of Education has also approved FSU's request to spend \$5,600,000 in HEERF funds for this project.

In February 2024, the FSU approved to increase the HWC project authority by up to \$1,000,000, funded by surplus funds from FSU's Bryant and Vance Hall Demolition project. The UNC System Office informed FSU that those funds were not allowed to be transferred to the HWC project because they were Repair & Renovation funds which are not eligible to be used on a project that is adding square footage.

The University's expanded Health and Wellness Center will



provide more health and wellness space, equipment and programming than originally planned. Because of the expanded size and scope of the facility, additional parking will also be required.

The University now seeks approval from the Board to increase project authority by an additional \$250,000. The increased authority will be funded from two sources:

- FY22-23 Carryforward funds
- FY20-21 Carryforward funds

SUBJECT Campus Wide Hardscape and Exterior Lighting Project:

Increase in Project Authority

BACKGROUND: The FSU Board of Trustees in March 2023 approved a

\$279,000 increase to an existing \$900,000 FY21-22 R&R project for campus wide hardscape and exterior lighting upgrades bringing total project authority to \$1,179,000. Since that time, an additional \$600,000 of FY23-24 R&R funds have been authorized by UNC Board of Governors. The

current total project authority is \$1,779,000.

An additional \$1,150,000 project authority is now being requested to enhance exterior lighting in the East Quad and elsewhere on campus. The additional project authority will cover additional design, material, and installation expenses, and will improve lighting, safety, and security on the FSU campus. The funding source for the additional authority is Title III FY21-22 Infrastructure Improvement Carryforward

funds.
