The Committee on Budget and Finance of the Fayetteville State University Board of Trustees convened Wednesday, December 13, 2023, in the Rudolph Jones Center Room 242 and via Microsoft Teams. Committee Chair Stuart Augustine presided and called the meeting to order at 1:01 p.m.

ROLL CALL

APPROVAL OF MINUTES

Trustee Kimberly Jeffries Leonard made a motion to approve the minutes of the Budget and Finance Committee meeting held on September 27, 2023, as distributed. Trustee Will Warner seconded the motion. The motion carried.

BUDGET AND FINANCE UPDATES

There were no information items to be presented at the meeting. Vice Chancellor Lillian Wanjagi presented the following recommendation for the committee's approval.

ACTION ITEMS

Action Item: BF-1: New Residence Hall Project Authority Increase.

The North Carolina Office of State Budget and Management approved an additional \$4,000,000 in project authority for the New Residence Hall project in April of 2023 bringing the total project authority to \$44,000,000. An additional \$6,000,000 in project authority is now being requested to support the construction of the 336-bed residence hall and cover additional expenses due to the escalation of construction costs. The additional project authority will be debt financed and repaid via future housing receipts.

Any increase in project authority must be approved by the FSU Board of Trustees and the

UNC Board of Governors. Further, self-liquidating debt authority must be approved by the FSU Board of Trustees, the UNC Board of Governors and the North Carolina General Assembly.

Trustee Glenn Adams made a motion to approve the University to seek UNC Board of Governors approval for \$6,000,000 in self-liquidating debt authority and to increase the New Residence Hall project authority by \$6,000,000 to a total of \$50,000,000, with final approval by the UNC Board of Governors. The motion was seconded by Trustee Will Warner. The motion carried.

ADJOURNMENT

The Budget and Finance Committee adjourned at approximately 1:14 p.m.

New Residence Hall: \$50M project authority, 340 beds, 4 stories, 78,093 SF. Construction began 11/30/23, completion Fall 2025.

<u>New College of Education</u>: \$69.3M project authority, 4 stories, 70,495 SF. Currently entering the final phase of design. Construction estimated to start Fall 2024. Completion date estimated Summer 2026.

<u>New Parking Deck</u>: \$10M project authority, current design 225 spaces. Seeking additional funding to increase to 285 spaces. Design estimated to be complete Summer 2024 and construction estimated to be complete in Fall 2025.



Bryant & Vance Hall Demolition: \$2.5M project authority. Project estimated to be complete in April 2024 and leave an estimated \$750k surplus to transfer to the new HWC project.

<u>New Health & Wellness Center</u>: \$11.1M project authority, 2 stories, 24,000 SF. Design phase estimated to be complete by Summer 2024 and construction estimated to be complete in Fall 2025.

<u>Chick Building Renovation</u>: \$9.5M project authority. Request for \$2.7M in additional funding included in UNC System's Legislative priorities. Design phase estimated to be complete by Summer 2024 and construction estimated to be complete in Summer 2025.



Rosenthal Building Renovation: \$10M project authority. Request for \$3.0M in additional funding included in UNC System's Legislative priorities. Design phase estimated to be complete by Summer 2024 and construction estimated to be complete in Fall 2025.

<u>Utility Infrastructure Renewal</u>: \$9.95M project authority. Design underway on a multi-phase project estimated to finish in early 2027.

Cook Building Renovation: \$10M project authority. Designer selection made February 2024. Design phase estimated to be complete by Spring 2025 and construction estimated to be complete in Summer 2026.



Butler Building Renovation: \$3.745M project authority. The building envelope subproject is out to bid and construction is estimated to be complete in Spring 2025. The HVAC/fire alarm subproject is still in design and construction is estimated to be complete in Summer 2025.

East Quad Renovation: \$1.179M project authority. The project is currently in design and we are attempting to increase the project authority and expand the project scope. Construction is estimated to be complete in Fall 2024.

Bronco Midtown Renovations: \$1M project budget will resurface the parking lot, replace the entrance sign, refresh the building façade and renovate several rental suite interiors. The project will be completed in Summer 2024.



<u>New Starbucks</u>: the project is under construction in the East Quad and scheduled to be completed and opened in Summer 2024.

<u>New Chick fil A</u>: the project is under construction at Bronco Midtown and is scheduled to be completed and opened in Summer 2024.

<u>University Advancement Renovation</u>: project authority \$1.55M. Design in final phase and project will be complete in December 2024.



Paige Alumni House Renovation: construction is underway and will be complete in June 2024.

BACKGROUND:	The UNC Board of Governors requires the Board of Trustees to approve the selection of a Construction Manager at Risk ("CM at Risk") upon the constituent institution choosing that method of construction delivery. The CM at Risk guarantees a maximum price (GMP) for a project's cost of construction.

- Proximity to and familiarity with the area where the project is located.
- Quality of compliance plan for minority business participation as required by N.C.G.S. 143-128.2.

Campus Wide Utility Infrastructure Project Construction Manager at Risk Selection

Project Scope

Fayetteville State University's Utility Infrastructure Project entails a thorough modernization of the university's underground utility systems, encompassing electrical, distribution, stormwater drainage, and natural gas distribution. The primary objective of the project is to tackle critical issues such as aging infrastructure, deteriorated sections, and corroded piping. The project's primary emphasis is on the replacement of the aging medium voltage electrical system, with additional attention given to stormwater repairs and natural gas piping replacement. The project budget is \$10,000,000.00.

Definition - Construction Manager at Risk

Construction Management at Risk is a contracting method authorized by the State of North Carolina. The Construction Manager at Risk (CMR) is selected on a qualification-based solicitation typically at the beginning of the design process and, working with the Owner and Designer, provides constructability input and cost estimating advice during design. When the construction documents are reviewed and approved by regulatory agencies, the CMR provides a GMP (guaranteed maximum price) acting as a construction manager to deliver the project.

The CM at Risk must publicly advertise for and pre-qualify all "first tier subcontractors," must comply with the state MBE program requirements and open all bids in a public venue. All bids become public records.

Project Scope

Fayetteville State University's Spaulding Building Renovation Project will renovate the 7,360 SF Spaulding Building, which currently houses the FSU Student Health Center and the Center for Personal Development. When the new FSU Health and Wellness Center project is complete in 2025, the Student Health Center will be relocated there. The University will renovate the entire Spaulding Building to deliver mental health and counseling programs and services to FSU students. The project budget is 1.3M.

The aging Spaulding Building is not designed to operate efficiently and safely in pandemic environments. The building renovation will address the deficiencies and provide improved ventilation and social distancing capacity.
