## UNIVERSITY ADVANCEMENT COMMITTEE WEDNESDAY, June 8, 2022 10:30 a.m.

The University Advancement Committee of the Fayetteville State University (FSU) Board of Trustees convened Wednesday, June 8, 2022, in the Rudolph Jones Student Center Room 242. Committee Chair Mr. John English presided, and the meeting was called to order at 10:30 a.m.

### **ROLL CALL**

The following Committee Trustees were in attendance: Glenn Adams, Doug English, Warren McDonald, and Greg Pinnix.

### **APPROVAL OF MINUTES**

It was moved by Trustee McDonald and properly seconded by Trustee Adams that the minutes of the University Advancement Committee Meeting held on March 23, 2022, be accepted as distributed. The motion carried.

### **DIVISION UPDATE**

Interim Vice Chancellor Chris Davis announced that Arielle King '09, was hired as the Assistant Director of Development, and that other important hires are in the process.

He provided an update on FY22 fundraising. Davis also shared a comparison between FY21 fundraising and the projected FY22 fundraising.

Mr. Davis then shared alumni giving in FY22 compared to FY21 and talked about our alumni participation rate.

He shared how important these rates are in fundraising, especially when soliciting corporate support and how they are factored into university rankings. Mr. Davis shared his plan to increase these rates next FY through increased engagement and a revamped annual giving program.

Mr. Davis also discussed where we stand with giving from corporations, foundations, and other organizations. He explained the reasons behind lower giving levels this FY and how current giving projections have them surpassing last year's totals. Mr. Davis spoke of goals as it relates to overall fundraising, alumni giving, and increasing the alumni participation rate.

Mr. Davis re-emphasized the importance of career readiness through experiential education and employment opportunities and shared an update on where we are with paid internships and graduate employment.

He closed by sharing with the committee how we could help in their efforts. Mr. Davis encouraged us to

- Continue supporting FSU financially
- Connect FSU with our network
- Continue to be an advocate for FSU
- Hire FSU students as interns and employees

There was productive and constructive dialogue between the trustees about strategies that we could employ to further assist the university and get the financial support FSU needs.

It was moved and properly seconded to adjourn the meeting at 11:00 a.m. The motion carried.

### **Strategic Priority 5 | University Sustainability**

Fostering a culture of sustainability is essential to the success of this university. This is accomplished by maximizing funding and aligning fundraising initiatives with university priorities

Goal 1: Increase baseline comprehensive fundraising to \$8 million

Goal 2: Increase Alumni support to \$1 million; Corporate and Foundation support to over \$6 million

Goal 3: Increase alumni donors to a minimum of 2,000 overall

Goal 4: Create an Annual Fund program and re-establish Planned Giving program to enhance sustainability efforts
