Abstract

Out-of-school suspension (OSS) is a major disciplinary tool that has impacted large numbers of students in the United States. Most research into OSS has drawn exclusively on data collected from school records and other "official" sources, and this body of work has contributed to our understanding of suspension decisions by school officials.
