### INSTRUCTIONS FOR USING THE IRS DATA RETRIEVAL TOOL

- 1) Access your 2021-2022 FAFSA application at <a href="https://www.fafsa.ed.gov">www.fafsa.ed.gov</a>
- 2) Enter your FSA ID.
- 3) Click on the Start 2021-2022 FAFSA button.
- 4) Click the Next button to start entering your Student Demographic Information
- 5) To access the IRS Data Retrieval Tool
  - a. Click the Financial Information TAB
    - If you are a <u>dependent student</u>, you will be directed to the Parent Financial Information section first and then to the Student Financial Information section.
- 6) Answer the IRS Data Retrieval Tool questions.
- 7) Click the option to Link to the IRS.
- 8) You will receive a message that you are leaving your FAFSA application and going to the IRS web site.
  - a. Click OK.
- 9) You must answer the following questions on the IRS Data Retrieval Site:
  - a. 2019 Filing Status Single, Married Filing Jointly, Married Filing Separately, Head of Household
  - b. Exact address used on your 2019 Tax Return
  - c. Click submit
  - d. Your 2019 tax information will populate the screen
  - e. Click transfer my tax information into the FAFSA application
  - f. Click Transfer Now
    - <u>DO NOT</u> make any changes to the information transferred from the IRS Data Retrieval process. No further documentation is needed to verify 2019 IRS income tax return information that was transferred into the student's FAFSA using the IRS DRT <u>if that</u> <u>information was not changed.</u>
- 10) Add Wage information from your 2019 W-2 (s) in the Income Information section.
  - a. Click Next.
- 11) Enter your FSA ID
- 12) Click Agree.
- 13) Click Submit My FAFSA Now
