<ul> <li>For borrowers with a Total and Permanent disability discharge: As a condition of Total and Permanent disability discharge, your obligation to repay your discharged loan or discharged TEACH grant service obligation will be reinstated if at any time during your three-year post discharge monitoring period you: <ul> <li>Have annual employment earnings that exceed the Poverty Guideline amount for a family of two in your state, regardless of your actual family size;</li> <li>Receive a new William D. Ford Federal Direct Loan (Direct Loan) Program loan or TEACH Grant;</li> <li>Receive a disbursement of a Direct Loan or TEACH Grant that you received before the discharge date is made, and you do not ensure the return of the full amount of the disbursement within 120 days of the disbursement date; or</li> <li>Receive a notice from the Social Security Administration (SSA) stating that you are no longer totally and permanently disabled, or that your disability review will no longer be the 5-year or 7-year review period indicated in your most recent SSA notice of award for Social Security Disability Insurance (SSDI) or Supplemental Security Income (SSI) benefits.</li> </ul></li></ul>	
The Office of Scholarships and Financial Aid will not disburse a Direct Loan or TEACH grant for borrowers with a Total and Permanent disability discharge until the month following the three-year post discharge monitoring period.
